(a) I, for myself and my personal representatives, executors, administrators, heirs, successors, and assigns, release and discharge the Hispanic Heritage Coalition, Fiesta Salsa, City of Elgin, and all sponsors of the 2007 Fiesta Salsa 2 Hot 2 Spicy Super Show, and each of their parent companies, subsidiaries, affiliates, directors, officers, trustees, professionals, members, employees, volunteers, agents, attorneys, successors, and assigns, all referred to collectively as releasee's, and individually as releasee from all liability for any injury, damages, death, property damage, or other laws based upon, arising out of or in any way connected with my participation in the 2007 Fiesta Salsa 2 Hot 2 Spicy Super Show, whether caused by any releasee's negligence or any other acts of omission; (b) I agree to indemnify each releasee from any loss, liability or damages which any releasee may incur based upon, arising out, or in any way connected with any of my acts or omissions that related in any way to the 2007 Fiesta Salsa 2 Hot 2 Spicy Super Show; (c) I assume full responsibility for of any and every damage, and, or any laws based upon, arising out of, or other laws based upon, or in any way connected with my participation in the 2007 Fiesta Salsa 2 Hot 2 Spicy Super Show, whether caused by any releasee's negligence or any other act or omissions; and (d) I agree that the preceding paragraph 3 (a) through (c) are intended to be as broad and inclusive as permitted under Illinois law that if any portion of any or all of those paragraphs is held invalid, the balance of them and this agreement will continue in full force and effect.
 4. I am prohibited from and agree not to display any pornographic material on any video system in or around the participating vehicle, nor am I allowed to emit any sound that can be heard from participating vehicle more than 75 feet from vehicle, per Elgin city ordinance. (*see disclaimer) Violation of such will result in immediate disqualification from the event in the vehicle will be ejected from the site. This paragraph does not apply to any contestant who has entered his/her vehicle and the sound off competition. During the time of their actual participation in said competition.
- **City of Elgin Ordinance 11.40.095**

Violators of the sound amplification ordinance will have their vehicle impounded. The vehicle is eligible for release upon posting to it up a \$250 cash bond at the Elgin police Department 151 Douglas Ave. Elgin, IL 60120, 24 hours a day. Upon payment of the Bond, you'll be provided with information to contact the tow company to retrieve your vehicle, 24 hours a day, after paying for applicable charges to the tow company. A preliminary hearing may be held upon request within 12 hours of the impound, to do so, the request should be made by calling 847-931-5600, voicemail box 9250, leaving the name of the requestor and the return contact number. A hearing will be held within 24 hours, excluding Sundays and holidays. The vehicle may be released without fees only if there is no probable cause. The contested points that would affect the decision are in the distance was at least 75 feet. This is not in lieu on going to court. The citation issued for this offense is a "Must appear" and will require that an appearance in court for the case to be heard and decided upon by the judge at that time.

I have carefully read this application and agreement, including the release and assumption of risk, and the indemnity paragraphs, know the contents, and sign this application and agreement voluntarily.
